

2. WIRELESS TELECOMMUNICATIONS PERMIT NO. 17

Core Development for Verizon; 12026 Front Street; a request to install a temporary wireless telecommunications facility at an existing parking lot.

Staff Recommendation: That the Planning Commission adopt Resolution No. 12-35 to approve Wireless Telecommunications Permit No. 17 subject to the conditions of approval contained in Exhibit "A".

3. CONDITIONAL USE PERMIT NO. 944 PRECISE DEVELOPMENT PLAN NO. 1900

Jenn and Karey L. Liao, Anchor Motel, 11632 Imperial Highway; a request to conduct the following:

- 1) Add eight (8) motel rooms for a total of sixty-nine (69) motel rooms; and
- 2) Modify the existing parking lot to add parking spaces.

Staff Recommendation: That the Planning Commission:

- (1) Adopt Resolution No. 12-36 to approve Conditional Use Permit No. 944 subject to the conditions of approval contained in respective Exhibit "A"; and
- (2) Adopt Resolution No. 12-37 to approve Precise Development Pan No. 1900 subject to the conditions of approval contained in respective Exhibit "A".
