

**2. SIGN USE PERMIT NO. 268**

Kasey Clark, AKC Services, Inc., 13111 Sycamore Drive; a request to replace the existing Doubletree Hotel and Norwalk Entertainment Center signage.

**Staff Recommendation:** That the Planning Commission adopt Resolution No. 13-31 to approve Sign Use Permit No. 268 subject to the conditions of approval contained in Exhibit "A".

**3. SIGN USE PERMIT NO. 270**

Outdoor Dimensions on behalf of Fast 5 Express, 11335 Firestone Boulevard; a request to establish signage for a previously approved carwash.

**Staff Recommendation:** That the Planning Commission adopt Resolution No. 13-32 to approve Sign Use Permit No. 270 subject to the conditions of approval contained in Exhibit "A".

**4. WIRELESS TELECOMMUNICATIONS PERMIT NO. 23**

Sequoia Deployment Services, Inc. for T-Mobile; 11755 Imperial Highway; requests to install a new clock tower with a concealed wireless telecommunications facility within the new structure in an existing commercial development.

**Staff Recommendation:** That the Planning Commission adopt Resolution No. 13-33 to approve Wireless Telecommunications Permit No. 23 subject to the conditions of approval contained in Exhibit "A".

**5. CONDITIONAL USE PERMIT NO. 840**

Juan Ramirez, 3-D Auto Repair; 11839 Firestone Boulevard; a request to modify a previously approved project to legalize the expansion of an auto repair use within an existing building.

**Staff Recommendation:** That the Planning Commission adopt Resolution No. 13-34 to approve Conditional Use Permit No. 840 subject to the conditions of approval contained in Exhibit "A".
